When credit is approved and established, the following credit terms will apply:

- Payment of an Open Credit Account is due and payable on the "Payment Due" date on your invoice.
- Italco Food Products Inc. reserves the right to change your payment terms to COD based on credit references and payment history.
- A finance charge of 1.75 % per month (21% APR) will be assessed to all 30 day plus balances.
- If the monthly statement shows a 45 day balance due and this amount has not been paid by the 15th of the month in which the statement is received, the account will be subject to collection procedures by our Legal Department.
- For each NSF check that our bank notifies us of, there will be a charge of \$20.00 for the first notification and \$40.00 for the second notification.
